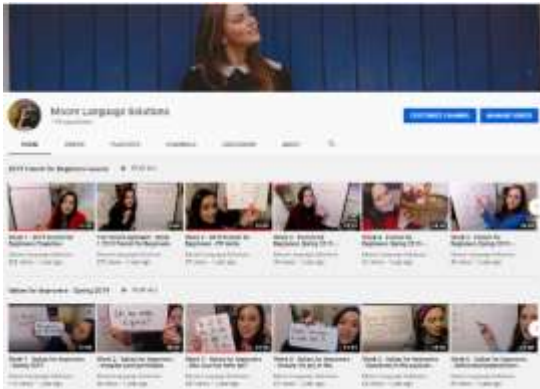

Please note that your digital club handout may be used for the sole purpose of the club member's personal reference. Please do not copy, publish or forward your handout to another individual without first obtaining written permission from Charlotte at Moore Language Solutions as this content is copyrighted and is available only to club members.

Language Tuition & Club Terms & Conditions

1. Details of your membership will be outlined in your digital receipt for your ease of reference. This receipt will be emailed to you following receipt of payment of your membership fee.
2. Membership fees remain the subject of annual review. Attendees will be notified by email of any changes in membership prices at least **14 days in advance of changes coming into effect**.
3. Membership can be paid in cash, by bank transfer or via PayPal prior to receipt of your first club handout and video link email. Payment details can be found at the bottom of this page.
4. All payments made by attendees will be followed up with a digital receipt by email within 14 days of receipt of funds.
5. From time to time, Moore Language Solutions may run limited-time offers on tuition/courses or club membership. Students can find information about these offers at our website -

8. Club members are entitled to a 10% discount on our private Language Tuition services; there is no limit on the number of lesson blocks you can purchase within a 12-month period. Please note that this discount cannot be used in conjunction with any other offer. 10. Each language club session handout and video shall be fit for its stated purpose and target readership/audience, and the level of quality specified. Unless specified otherwise, handouts shall be deemed to be 'for information' only.
11. Language clubs shall be carried out by Moore Language Solutions using reasonable skill and care and in accordance with the provisions and spirit of the Code of Professional Conduct of the Institute of Translation and Interpreting.
12. Representatives of Moore Language Solutions – or associated personnel – may take photographs/videos/screenshots/audio recordings of club activities for publicity purposes or for any other activity that helps us to achieve our professional objectives. Should you wish not to be photographed/recorded, please let us know in writing prior to paying your club membership fee. For lessons/clubs/courses/events undertaken in person, a hard copy disclosure form (on page 4 of this document) will be provided for ratification and collection prior to lesson commencement. Payment of your club membership fee will be taken as your acceptance of these terms.
13. Liability of Moore Language Solutions under or in respect of this agreement, whether in tort, contract or otherwise, shall be limited to the cost of the club attendee membership in place when the liability arises. Neither Moore Language Solutions nor the club attendee shall be liable the other in respect of any consequential or indirect loss whatsoever.
14. The contract incorporating these conditions shall be governed by British law and any matters arising out of it shall be subject to the jurisdiction of the Courts of England and Wales.
15. This Agreement shall come into effect either (1) when the attendee confirms the project in writing or (2) when Moore Language Solutions provides any services under the agreement, whichever is the earlier.
